**Job Title:** Fee-For-Service Psychotherapist

**Reports to:** Clinic Director

**Overview:** CASES' Nathaniel Clinic is located in the heart of Central Harlem at 7<sup>th</sup> Avenue and 125<sup>th</sup> Street. The Nathaniel Clinic seeks experienced therapists. We are a new outpatient mental health clinic serving justice-involved youth aged 13 and above and adults. CASES is pleased to offer part-time (approximately 10 – 20 hours per week) positions for social workers (LMSW/LCSW). We seek therapists to work with youth and/or adults, with availability to see clients during day, weekday evening (until 9pm), and Saturdays. CASES is committed to the ongoing training and supervision of its fee-for-service therapists. We offer robust training opportunities in the areas of evidence-based engagement, providing treatment to justice involved clients, risk assessment and risk management, motivational interviewing, trauma, dialectical behavioral training (DBT), integrated dual-disorder treatment, and group facilitation.

This is an opportunity for creative and self-motivated therapists to work as a member of a dynamic team with youth, adults, and families from culturally and socioeconomic diverse backgrounds.

- Provide compassionate clinical treatment and conduct initial assessments
- Use CareLogic Qualifacts electronic health record
- Complete collaborative/concurrent documentation
- Manage caseload in a busy treatment setting that uses centralized scheduling
- Develop recovery-oriented treatment plans in collaboration with the service recipient
- Coordinate care with clinic psychiatrists and onsite provider offering medical care
- Utilize evidence-based approaches to treatment that respond to serious mental illness, trauma, primary healthcare needs, and criminal justice involvement.
- Provide culturally competent services that are individualized to client needs and reflect the integration of race, ethnicity, culture, primary language, immigration status, developmental status, criminal justice status, sexuality, age, and gender.
